In my career, I've probably used everything that has been popular since 1974 - from printed volumes for programmed learning (an abomination) to interactive, virtual simulations. Canned stuff usually sucks. Materials developed by a professional "curriculum specialist" who either never talked to an SME or only talked to one always suck. Since my instructional design and delivery experience has been primarily technology-oriented, I've found that small groups where you can match skill and knowledge levels - or else pair people up with a mentor - and provide customized (often JITT) instruction works best.
